I represent Police Officer Shatorra J. Foster.

I previously submitted allegations to the Office of Equity and Inclusion and the Internal Affairs Bureau concerning serious misconduct, retaliation, failure to investigate, misuse of Department systems, and investigative contamination involving Trevlyn O. Headley and the Department's handling of respondent's pending disciplinary matter.

As of this writing, I have not received confirmation of receipt, assigned log numbers, or any response identifying the status of those submissions.

Please provide the assigned OEI and IAB log numbers, confirm that the allegations have been received and preserved, and identify the unit or investigator responsible for intake or review.

These allegations concern an active disciplinary prosecution and include issues bearing on respondent's statutory rights, victim-status protections, retaliation, selective enforcement, and the integrity of the underlying internal investigation. Respondent reserves all rights, including the right to seek appropriate relief in the pending disciplinary matter and in any related civil proceeding.
